Update: Community Conversations

Since the last issue of the Boulder County Voter, we have had three Community Conversations, in three different communities within Boulder County. We are very much in a learning process as we start this project of trying to increase our engagement in the community. Below is a recap of the first three conversations:

<u>January 28, 2016, Louisville Library, Topic: Common Core</u>. Evie Hudak from the Colorado PTA explained how the Common Core standards were developed and talked about some common myths. Approximately 15 people attended, mostly LWVBC members. 2 new members joined the League that evening. Members of the Schools Team provided refreshments and arranged the event.

<u>February 9, 2016, Longmont Chamber of Commerce, Topic: Public Transit</u>. Prue Larson moderated a panel discussion between Will Toor (Southwest Energy Efficiency Project), Judy Lubow (RTD board of directors), and Phil Greenwald (City of Longmont Transportation Dept.). Audience members then joined in with questions and comments. Approximately 34 people attended, including about 23 non-members. Ruth Stemler, Judy Burris, and Shiquita Yarbrough provided refreshments and made the arrangements.

<u>February 10, 2016, Boulder Chamber of Commerce, Topic: Living Wage</u>. Ken Miller from KGNU radio moderated a panel discussion between Carmen Atilano (City of Boulder Office of Human Rights and Community Relations), Aubrey Hasvold (Colorado Center on Law and Policy), Mary Young (Boulder City Council), and Christina Suarez (Latino Task Force of Boulder County). Audience members also asked questions. Approximately 30 people attended, including at least 20 non-members. Members of the Social Policy Team provided refreshments, and the speakers were arranged by the Self-Sufficiency 2016 Coalition. The program was broadcast on KGNU radio on February 24.

VOTING AND BALLOTS

ALL REGISTERED VOTERS WILL RECEIVE A BALLOT IN THE MAIL

Voters may complete the ballot and return it by mail, or take it to a drop-off location

A mail ballot must be received by the county clerk no later than 7 PM on Election Day

Voter Service and Polling Centers will be located in each county to provide election services. Services include:

- Voter registration at any time up to and including Election Day
- Voters may change their address if registered elsewhere in Colorado
- Voters may drop off their completed ballot
- Voters may surrender their mail ballot and cast their vote in person
- Voter Service and Polling Centers will be open at least 10 days before the Primary Election and at least 15 days prior to the General Election.

IDENTIFICATION

To vote in person, a voter must show an acceptable form of ID. When voting for the first time by mail, a voter may be required to send a copy of an acceptable form of ID.

League Members in Action

Taking Action: Remarkable National League Leader Coming to Boulder County

Mary Wilson is coming to Boulder, and we will have the opportunity to hear her speak on "Immigration: Where Do We Stand and What Can We Do?"

If you haven't been in the League for very long, you might ask, "Who is Mary Wilson?" She is an attorney practicing in New Mexico, and she is past national League President, which demands anyone's respect. Her two terms spanned the period from 2006-2010 when our current President, Elisabeth MacNamara, was elected.

During her tenure, the national study on Immigration was undertaken. Also Vote411 was initiated during that time. Mary lobbied for the Affordable Care Act, and, immediately after the Citizens United decision she testified before a Senate Committee chaired by Sen. Dianne Feinstein, encouraging the Senate to develop and pass legislation that would at least require more disclosure about the contributors to PACs. (Mary says that during the hearing, Sen. Feinstein took the opportunity to tell everyone that she got her start in politics as a member of the League.) She was honored by Oxfam with a Sisters on the Planet Climate Leader award because of her personal work on the issue of climate change, particularly lobbying Congress about the adverse effect climate change was having on women around the world.

She lives with her husband on a ranch that was homesteaded by her husband's grandfather in 1914. She originally comes from that part of Ohio which is near where Ohio, Kentucky and West Virginia come together.

Because of her knowledge and expertise, Mary was invited to participate in the Conference on World Affairs this year. Since she is in town anyway, she has graciously agreed to be the center point for an LWVBC event.

Taking Action: Doing Democracy Day (DDD)

This annual event provides young people who are interested in politics the opportunity to meet with peers from other schools in the area and consider the pros and cons of implementing changes in public policy. This year DDD VII is Tuesday March 29th at the Longmont Civic Center and our local league is a co-sponsor. Why? This fits with our strategic goals of increased engagement with youth and seeking to be more visible in our community.

Each student participant is randomly given one of 6 questions to consider and assigned to a team with 4 or 5 others. In the morning the teams learn more about their issue, agree on the position they will take, and prepare and rehearse a presentation meant to win the audience over to the stand the team has taken. In the afternoon all teams make their pitch to one of several sets of volunteer judges. All but the best-performing teams are eliminated in the first round and in the final round the judges do a ranking of the teams after watching repeat performances of those teams' presentations.

You can assist with this event as a resource for student interviews in the morning or a judge in the afternoon. DDD needs individuals who can speak on the "how it's done" aspect of public policy as well as those who have special knowledge of the issues. Coffee, morning snacks and even lunch are provided and wearing a League button is an easy way to make our organization better known. The issues students will consider are these:

- Should local communities petition the state to change laws and allow 16 year olds to vote and serve on city council and school boards if elected?
- Should local communities drastically reduce enforcing laws against homelessness and focus instead on providing support services including mental health treatment?
- Should cities allow marijuana shops and use the tax money on prevention programs in middle schools?
- Should St. Vrain institute a required training program for school personnel on LGBT awareness and sensitivity?
- Should the St. Vrain Valley voters be asked to increase local taxes to provide college and post secondary training scholarships for all local students?
- Should local communities restrict private drone use in city limits?

Taking Action: Living Wage Victory

From the Social Policy Team

At the Boulder City Council meeting on Tuesday, 16 February 2016, the City Council took the first steps to bring some contract workers back into the City employment system. LWVBC Social Policy Team members, as part of the <u>Self-Sufficiency 2016 Coalition</u>, participated in the discussion that led to this plan.

The Social Policy Team along with the Self-Sufficiency 2016 coalition presented their resolution to Boulder City Council on Tuesday February 16. The resolution asked the City Council to:

- Reaffirm the interim measure by the City Manager to raise wages of part-time and temporary city employees as of Feb. 2016.
- Pay all city employees and all employees of city contractors a Living Wage.
- -Pay all employees of for-profit contractors of the city a Living Wage for all hours they work on City of Boulder projects.
- Establish the living wage at \$15.67 per hour, based on the Self-Sufficiency Standard for Boulder County.
- Pay a higher living wage to those city employees and employees of for-profit contractors who are not provided benefits.
- Direct city staff to create an ordinance consistent with the above conditions which shall relate to wages, benefits and working conditions.
- Direct the city to work to overturn the state-wide ban on local minimum wages.

Ruth Stemler and Mary Ann Wilner from the LWVBC; Amy Zuckerman, Commissioner of the Human Relations Commission and Laurel Herndon of the Self-Sufficiency 2016 Coalition testified at the meeting. In addition, the Social Policy Team invited other community members to speak to council. Claire Levy, Rabbi Fred Greene, former Boulder Chief District Judge Roxanne Bailin, Judy Nogg and others gave thoughtful, forceful speeches.


Council members Sam Weaver, Lisa Morzel, Aaron Brockett and Mary Young were staunch advocates for using the Self-Sufficiency Standard of \$15.67 and for ensuring that contract workers who are without benefits are paid a higher wage.

Council members Matt Applebaum and Bob Yates, wanting to avoid renegotiating contracts, suggested the city bring the custodial and landscape workers back in-house as city employees. Jan Burton expressed concern that existing city employees may want comparable raises, a situation called "wage compression."

By the end of the more than two-and-a-half-hour discussion, the council had voted to:

- Bring the custodial and landscape contract workers back in-house by Jan. 1, 2017, pending cost analysis by city staff; (9-0 vote).



Voter Registration Services 2016 Voter Registration Drive Circulator Training

Dear Boulder County League Members:

We are gearing up for a very busy 2016 Voter Registration Drive (VRD) season. We will be conducting numerous VRDs throughout the county between now and October 17th and hope you can volunteer as a Circulator (someone who helps sign people up to vote) as your schedule permits.

Because voter registration and voting are fundamental to our democracy, anyone participating in 2016 VRDs must complete a short VRD Circulator Training. (This is true even if you trained as a VRD Circulator in a prior election year). Please complete the following Circulator Training steps:

First, watch the short Secretary of State Circulator Training video: <u>Click here</u> to view online. [Note: There is no audio. You can stop at each frame by clicking the symbol on the bottom left side of the screen. When you have finished viewing the video close all the screens.]

Second, read the attachment "2016 Voter Registration Drive Training Tips" found here: <u>View Online</u>.
