## **Doing Democracy**

Liz Black, (See photo below), Diana Barney and Ruth Stemler represented our League by participating in the Sixth Annual "Doing Democracy Day" (DDD) at the Longmont Civic Center on April 21. The event was sponsored this year by the St. Vrain Valley School District Superintendent's Office, the Silver Creek Leadership Academy, the St Vrain Valley Education Association, the City of Longmont, Lessons on Local Government (brought to you by Colorado Municipal League and Special District Association), CU, Sunflower Bank, LiveWell Longmont, Longmont Area Chamber of Commerce-Education Committee, and CENTRALongmont (a Presbyterian congregation). The event is a multi-community, multi-school event devoted to area students wrestling with local issues. Local leaders, such as the LWVBC reps, participate as resources in the morning and judges in the afternoon. Students are challenged to work on a team and create a presentation in which they give an overview of a problem, discuss merits of alternative solutions and tell the panel of judges their recommendation. Each government teacher brings up to five students who are not told in advance the problems to be considered. On DDD they are randomly assigned to teams of peers from other schools and given their topic.

Approximately 60 high school students from the St. Vrain School District and the St. Vrain community participated. Among the schools represented were Silver Creek, Skyline, Niwot, Longmont, Lyons, Erie, Frederick, Twin Peaks, and Mead. The students were gaining experience with public policy issues such as minimum wage, race and justice, plastic bags, immunizations, mental health and student participation on school boards. Kent Willman, CU instructor, and Carrie Adams, Silver Creek High School, organized and coordinated the event. This was a great opportunity for the League to learn from and network with the students and many community leaders. And LWVBC has been invited back for next year.



# **President's Ponderings**

Thank you to members that attended April Community Meetings— we got some great feedback on issues of importance in our community and ways our League can be more effective! As part of our *Strategic Planning*, we'll be compiling and reviewing that feedback.

Also within the scope of *Strategic Planning*, we are in process of community outreach— looking for opportunities to create partnerships for the League by interviewing staff in professional organizations and youth related programs as well as leaders in the Latino community. I'm enthused about magnifying our efforts through partnerships. Thanks to all who've been working on reevaluating/reinventing our League."



## Money in Colorado 2014 Elections

The Center for Responsive Politics/ Open Secrets, provides information on the money spent in the Mark Udall, Cory Gardner race for the U.S. Senate. They include the names of the group or organization making each contribution and whether the money was spent supporting or opposing a candidate. Most of the information comes from reports to the FEC. Some of the information on 501c spending came from other research. Totals of the monies spent by liberals and conservatives are shown in the table below.

#### **Udall/Gardner Race:**

|                     | Liberal      | Conservative |

This race was seen as critical to the control of the U.S. Senate. The total money spent was at least **103 million dollars**, most of it coming from out of state and from extremely wealthy individuals and groups.

The Sunlight Foundation/Open States provides information on the money raised by the winners of Colorado's U.S. House races in 2014.

**Mike Coffman** was re-elected to represent Colorado House District 6. He received contributions of \$3,896,386. The interest group providing the largest funding for his campaign was the oil and gas industry. This included contributions from Koch Industries and ExxonMobil.

**Ed Perlmutter** was re-elected to represent Colorado House District 7. He received contributions of **\$2,168,934**. The interest group providing the largest funding for his campaign was banks and credit with lawyers/law firms a close second. Contributors included Capitol One, First Bank, JP Morgan Chase and Wells Fargo.

**Scott Tipton** was re-elected to represent Colorado House District 3. He received contributions of **\$1,328,802**. The largest interest group funding his election was the oil and gas industry. The contributors included Haliburton.

**Jared Polis** was re-elected to represent Colorado House District 2. He received contributions of \$1,276,783. The interest group providing the largest funding for his campaign was the Democratic Party of Colorado.

**Ken Buck** was elected to represent Colorado House District 4. He received contributions of **\$1,111,008**. The interest group providing the largest funding for his campaign was the oil and gas industry. Contributors included Cade Oil and Gas.

**Diana Degette** was re-elected to represent Colorado House District 1. She received contributions of **\$948,577**. The interest groups providing the largest funding for her campaign were the pharmaceuticals/health products and health professions about equally. Contributors included Jstreetpac and Abbott Laboratories.

**Doug Lamborn** was re-elected to represent Colorado House, District 5. He received contributions of **\$507,505**. The interest group providing the largest funding for his campaign was the oil and gas industry. Contributors included Koch brothers, Honeywell, Northrup Grumman and Lockheed.


The bulbs come directly from a grower in Holland and are of very high quality. The spring I have beautiful crocuses and daffodils from the bulbs I purchased last year!

# NATIONAL LEAGUE NEWS

## THE U.S. CONSTITUTION: TO AMEND OR NOT TO AMEND?

The League of Women Voters has long supported the Voting Rights Act and legislation limiting the role of money in politics. Supreme Court rulings have negated important sections of the Voting Rights Act and gutted Campaign Finance laws. Whatever else it may or may not have done, the Court's rulings have galvanized a huge groundswell of citizens to act. New civic organizations have sprung up across the country, proposals for Constitutional amendments proliferated and action was demanded from regulators and Congress. What to do? Given Congress's unwillingness or inability to propose Constitutional changes, some are advocating using other tools provided in the Constitution for amending the Constitution.

Article V of the U.S. Constitution provides two ways for proposing Constitutional changes: Congress, by a two-thirds vote of both chambers, may propose constitutional amendments to the states for ratification. OR, the legislatures of two-thirds of the states (34 at present) may ask Congress to call a national convention to propose amendments to the Constitution. Amendments proposed by either of these methods must be ratified by three-fourths of the states (38 states) either by state legislative action or through state conventions called expressly for the purpose of voting on ratification.

The fall 2015 League of Women Voters study of the Constitutional Amendment process will seek member agreement on the path we should advocate for amending or nation's Constitution. How would the Article V Convention process work? What would be the role of the states? Who would decide the topics to be considered in the Convention? How would delegates be selected? How would delegates be apportioned? How would the ratification process work if the Convention proposes multiple amendments? Would the Convention's action be re-viewable in federal or state courts?
