## The 2019 Election – That's a Wrap

The 2019 Voter Service (VS) Team consists of over 50 volunteers many of whom are new to VS. Although the number of ballot issues and candidates were far fewer than what VS has had to address in prior election years, 2019 provided a big learning curve for many of us as well as a great dress rehearsal for what's on the horizon in the 2020 elections. I say "elections" because in 2020 there will be three elections: the presidential primary on March 3<sup>rd</sup>, the state and Congressional primary on June 30<sup>th</sup> and the general election on November 3<sup>rd</sup>. There will also be a Caucus for non-presidential candidates on March 7.

By the numbers, the VS Team made significant contributions to registering and educating voters in advance of the 2019 coordinated election through:

<u>Voter Registration Drives</u> - Thirty-eight volunteers completed the mandatory Secretary of State VRD training in order to register voters. Nineteen VRDs were conducted throughout the county between April and October at a variety of venues. Over 175 voter registration forms were filed on behalf of new voters or those updating their voter record. At the VRDS, volunteers answered a host of questions about voter registration laws, political issues and the LWV.

<u>Candidate Forums</u> - Led by Coordinator Josephine Porter, these

volunteers conducted six candidate forums (CFs) either independently or in partnership with other organizations concerning school board and municipal races. Five of those CFs



(i.e., the Boulder, Broomfield, Lafayette and Louisville city council races and the BVSD Board race) were videotaped and are available for viewing by going to the lwvbc.org homepage, clicking on the "News" pull down and then "watch our videos." (continued on page 7)

What do these places have in common?

Maine, Santa Fe and Eastpointe (MI) -- All recently switched from plurality elections to a different voting method.

Fargo and Mission Viejo (CA) - Both will be using a new voting method in 2020.

Lowell (MA) and New York City - Both will be voting In November 2019 on whether or not to adopt a new voting method.

Lane County (includes Eugene, OR), St Louis and the US Congress - Activists are gathering signatures or votes to adopt better voting methods.

Why are voting methods such a hot topic? Find out at our November 10<sup>th</sup> Community Conversation with CU Professor Jeanne Clelland. Learn about the adoption and use of ranked voting, cumulative voting, approval voting and proportional representation in the communities named above.

# About Those Grocery Cards ...

Grocery cards can make a significant contribution to the League. During a recent three-month period, the League of Boulder County received over \$500 from only 22 households. Imagine what we could do if even three-fourths of our member households participated!

#### King Soopers Loyalty Card Program

At last - it has been made easy to take advantage of the King Soopers Community Rewards program! No need to refill your card; your purchases will be tracked for the rewards program when you scan your King Soopers card at checkout. Pay with your usual credit card and continue to receive benefits from that company. Here's how to enroll:

- Have your King Soopers Loyalty card in hand or get one from King Soopers Customer Service. This is the card you use to get discounts on items sold at the store.
- Call 800-576-4377 Option 3 and give the customer service representative your loyalty card number to link your loyalty card to the Community Rewards Program to benefit the League of Women Voters of Boulder County. It should not be necessary to give the code for LWVBC, but it is FQ065. A Customer Service Representative will assist you so that your purchases at King Soopers count toward earning a rebate of funds to benefit LWVBC AT NO EXTRA COST TO YOU!! Just be sure to show your loyalty card every time you shop at King Soopers.
- \* Or, if you have an account with King Soopers, you can just go online and select LWVBC (FQ065)

#### Safeway Card Program

No changes at Safeway - continue to use your Safeway loyalty card to make purchases, and refill it from your preferred credit card when it runs low. You can put whatever amount you choose on the card, and each time you do so, it counts toward any benefits your credit card company offers, such as trip mileage.

- Contact <u>funddevelopment@lwvbc</u> to purchase a refillable Safeway card at \$10 each.
- Add money to it at a checkout or customer service counter and use it to pay each time you shop. Your purchases will earn money for LWVBC AT NO EXTRA COST TO YOU!
- Using a credit card to add money to your Safeway card allows you to benefit from applicable cash back or rewards programs the credit card offers.

## Contribute Disbursements from Your Retirement Account to Benefit LWVBC

Take advantage of disbursements from your IRA or similar retirement fund to support the League of Women Voters of Boulder County! And do it soon, to make the most of the potential tax benefit. If you receive your Required Minimum Distribution from an IRA, that income is taxable for 2019. Because most retirement contributions made while you are working are *not* subject to withholding at the time of the contribution, annual distributions made directly to you *are* taxable.

#### Here's how to benefit the League:

Call the investment manager(s) who handle your retirement savings account and tell them the
amount of your Required Minimum Distribution (RMD) that you wish to be given to the League of
Women Voters of Boulder County (LWVBC). You'll need the name, address and perhaps contact
information:

- Your financial manager can issue the payment directly to the LWVBC. You will **not incur the tax liability** that normally occurs with that portion of your IRA distribution, because the funds go directly to a charitable organization.
- The 1099R you receive next spring will still include the amount donated to the LWVBC in the total. You or your tax preparer will need to report the entire amount on the IRA line and subtract the amount donated from the taxable amount. Of course, you need to keep copies of your paperwork to back up your donation.

Some firms begin making distributions before year-end, so act quickly. Once a check has been issued to you, the opportunity for tax savings while benefiting the League is lost. And notify the LWVBC of your gift; sometimes investment managers do not note the donor when they issue payments directly to a charity.

<u>Ballot Issues</u> - Five volunteers selected a municipality and collected information on ballot issues (Bis) being considered by 'their' municipality, attending city council meetings and hearings, speaking with community leaders and monitoring community conversations in local publications. When the muni clerks published the finalized BI language, the volunteers wrote a summary of the major provisions, background and pros and cons of each BI. League webmaster, Deborah Hayes and I then reviewed and formatted the BIs for brevity and accuracy before arranging for printing and collation of over 1500 BI BI brochures. The brochures were then distributed by four volunteers at muni public libraries and in conjunction with 13 BI presentations at public and private venues throughout the county.

<u>VOTE411</u> - Led by Coordinator Stacie Johnson, six volunteers collected information on all candidate races, sent out invitations and board approved questions to the candidates and monitored candidate responses. This group also posted the finalized BI information on the VOTE411.org website. Please visit the VOTE411.org website and tell your family and friends about this invaluable nationwide voter guide!

My sincere thanks to each VS Team member who, through their dedication, provided voters with the desire, knowledge and confidence to participate in the 2019 election. That's a wrap!







#### IN MEMORIAM

Patricia Long Johnson was born July 26, 1926 in Maryland, and died on October 18, 2019. She graduated from Oberlin in 1948, and worked at the Educational Testing Service in Princeton, New Jersey. She then went to work for the CIA, serving in Washington DC, Vienna, Austria, Mexico, and Saigon, Vietnam. Pat and her husband Bill Johnson retired in 1976 and moved to Boulder the next year. Pat was very active with the League of Women Voters, serving as president for the local League from 1985 to 1987, and the state League from 1989 to 1991. Pat started the LWVBC Voting Methods Team and was active campaign finance reform. Pat and Bill were also involved with the Conference on World Affairs and the Colorado Music Festival.
