## League of Women Voters of Boulder County 100th Anniversary

### 100 Years Strong: Celebrating LWV in Boulder County!

Nearly 100 people gathered on March 1 to celebrate the League's 100<sup>th</sup> Anniversary, and kick off a new century of voter service and advocacy in Boulder County. The event was a great success, and we raised several thousand dollars to support our work in 2020.



The event featured LWVBC member Hannah Rain Crowe and her inspirational "[She Is Me - Colorado](#)" photojournalism project; and an historical monologue by Susan Marie Frontczak as "Eleanor Roosevelt." Frontczak's monologue was set in 1950, with Roosevelt reminiscing about the 30<sup>th</sup> Anniversary of the 19<sup>th</sup> Amendment, and the responsibility of women to not just vote, but take action about voting rights for all people.

Event participants also enjoyed a delicious appetizer buffet, drinks and conversation with League and community friends, new and old.

LWV has been celebrating its 100<sup>th</sup> Anniversary for the past few weeks! On February 14 (the actual anniversary), the League was honored in both the Colorado House and Senate. Later that day, at the LWVCO Legislative Conference, Governor Polis read a proclamation honoring the League.

On a local level, LWVBC received a proclamation from the Colorado Senate (courtesy of Sen. Mike Foote), and another proclamation from the Boulder County Commissioners. And, of course, we celebrated our 100<sup>th</sup> at the JCC on March 1, with a wonderful party. Thanks to all who worked so hard to make this a successful event!

Our Annual Meeting will be on April 25. The Nominating Committee and the Budget Committee are wrapping up their work. Issues For Action Planning (formerly known as Program Planning) took place during February, with members participating in 2 meetings, and the results are being reported to the state and national Leagues. And, at its February meeting, the board approved a new local position on the rights of non-citizens. Thank you to all who have worked so hard to get these items accomplished. They will all be reported to members on approximately March 25 (1 month before the Annual Meeting), and members (you!) will then vote on them at the Annual Meeting. We hope to see many of you there.

In addition, we will be presenting awards to our members and community partners at the Annual Meeting. Please send your nominations to Debby Vink by March 15. This is always a very special part of our Annual Meeting.

Our Voter Service Team has been, and still is, very active during this major election year. They will be conducting a candidate forum in Erie on March 12, and they continue to conduct Voter Registration Drives around the county. LWVBC volunteers will be involved in some Census Questionnaire Assistance events around the county, too.

It is always so nice to see our members at events, meetings, and coffees. We encourage you to participate if you can, and we are looking forward to seeing many of you in the coming months. We appreciate your support!

### Census News

April 1, 2020, is Census Day, and this is the first census that can be completed online. You can also respond by phone or paper form. Letters from the Census Bureau will start arriving in your mailbox on approximately March 12. You are encouraged to complete your census questions as soon as possible, to avoid further mailings. The self-response time will last through May 12, and then Census workers will be sent out to talk to people who have not yet responded.

Here are some other important things to remember about the census:

1. It's simple. It takes less than 10 minutes to complete the questionnaire, and you can complete it a number of ways (online, phone or mail).
2. It's safe. Your responses are protected by law, and confidentiality is guaranteed.
3. It's required. The law requires that everyone living in the U.S. participate in the census.
4. It's available online in 13 different languages, and there are guides in 59 languages.
5. It will not ask for your Social Security number, your bank account or donations.

Please spread the word about the importance and safety of the census to ensure that **Everyone Counts in Boulder County!** There will be Questionnaire Assistance events throughout the County for anyone needing assistance.

### **US and Colorado Voting Methods News**

*By the Voting Methods Team*

The competitive presidential nomination process is highlighting the way voters choose elected officials. Better voting methods are again generating a huge amount of interest!

**Update on possible LWVUS concurrence language** - Last month we reported on a possible compromise for the problematic bullet point in the proposed Voter Representation/Electoral Systems concurrence. LWV Maine responded, suggesting the following, even better, language:

“Whether for single- or multiple-winner contests, the League supports electoral methods that ...

- implement alternatives to plurality voting that improve the election experience and more accurately represent voter preferences.”

The language comes almost directly from the LWVCO position so we are very pleased with the language! According to the concurrence proponents, “The LWVUS decides on language” after the Program Planning reports are submitted. We are now in wait-and-see mode.

**Next step - Voting Methods Team applied to lead an LWVUS convention caucus**

Before the March 2<sup>nd</sup> deadline, we applied for a caucus to advocate for an amendment to the proposed national concurrence. Applicants will be notified of LWVUS decisions by March 13<sup>th</sup>.

The Fair Representation Act would create multi-member congressional districts - virtually eliminating gerrymandering - and conduct elections using a proportional multi-winner ranked voting method known as single transferable vote (STV). [STV is a good version of Ranked Choice Voting (RCV). Remember that RCV is an umbrella term for several different versions - some worse than our familiar plurality voting.]

The Voter Choice Act would provide up to \$40M in federal matching funds to support state and local governments transitioning from our familiar plurality voting to either instant-runoff voting (IRV) or single transferable vote (STV). Prior to the act's introduction, LWVCO sent a letter to Sen Bennet asking him to consider funding a variety of better voting methods, not only IRV and STV.

**Approval Voting citizens' initiative is collecting signatures for the fall ballot**

Four Democracy Initiatives intended to improve elections were created by Nathan Clay's campaign for US House of Representatives, District 7. If the Approval Voting initiative collects enough signatures, it will ask voters to adopt approval voting for state and local elections.

Long time members will remember Nancy, who was a stalwart member of LWVBC back in the '80s and '90s. She was well-remembered as a part of the Alternatives to the Automobile, or ATTA girls. She organized many bicycle counting sessions when one would sit at an intersection and record a complicated diagram of bicycle traffic to illustrate to City officials the flow of bicycle traffic. Nancy had moved to Fort Collins in recent years after being inactive in the League for several years. Her heart was with us, even after her ability to participate had departed.
